#### Wait, who owns the house?

Real estate is often sold as part of an estate administration. Clients are regularly surprised to learn that the house that has been in the family forever, passing from generation to generation or family member to family member, is riddled with title

issues, making it impossible to sell until clear title is obtained. Darcy regularly works with real estate attorneys and title counsel to clear title to real estate, lending her expertise in probate and land court in order to ensure the sale of real property.

## Avoiding Conflict in Trust Administration

At the death of her mother, a client sought assistance with the administration of her mother's trust of which she and her two siblings were the beneficiaries. Her mother had made certain advancements to one child during her lifetime which had not been clearly documented. Darcy crafted a Non-Judicial Settlement Agreement that all children agreed to execute, avoiding conflict within the family and the efficient administration of the trust.

## Appointing a Successor Guardian

The parents of an incapacitated adult child served as guardian of the child until their deaths. James, a sibling of the incapacitated person, was incorrectly advised that he had been appointed as successor guardian of the incapacitated person and held himself out as such for years. Upon meeting with James and discovering that he was not in fact appointed guardian, Darcy assisted James in properly petitioning the Court for appointment as guardian and advising him in connection with his ongoing obligations as such.
