Commercial litigation

- Obtained full dismissal of insurance carrier's \$7M indemnification claims against client brokerage firm, relating to a customer's claims against carrier for lapse of variable annuity policy sold by brokerage firm's financial advisor.

- Obtained \$500K settlement against former insurance executive and his new company on claims for breach of fiduciary duty, trade secret misappropriation, and breach of non-recruit and confidentiality agreements relating to executive's taking of client's confidential information and recruitment of client's insurance team
